### **2019/20 CRSA Scholarship Information:**

It is the policy of the Cedar River Soccer Association (CRSA) to assist those members who need financial aid so that an individual's ability to pay dues is not the sole deterrent to play soccer. Each year funds are used to support full and partial scholarships.

Financial need must be established annually through completion of the *Financial Assistance Request Form* (available online). Applicants must provide proof of income. Financial need takes into consideration family size, unusual or extraordinary expenses and situations. The requested information is kept confidential.

Scholarships are subject to the approval of the CRSA Board. Scholarships are granted to cover annual membership fees and **does not cover cost of uniforms, tournament entry fees, league fees, travel expenses, etc.** Scholarship funds are allocated among qualified applicants and scholarships can be awarded to cover either full or partial fees.

Players who have been awarded scholarships have an expectation to participate in club and team activities, as well as conduct themselves in an appropriate manner in order to maintain *active* status. Families of scholarship players are expected to volunteer their time to club related activities and activities associated with player's team. Scholarships can be revoked for non-adherence to the above requirements and expectations.

### **Eligibility**

1. Assistance will be granted annually on the basis of financial need. Eligibility criteria are based on the income Financial Guidelines for Scholarships below. All membership applicants will be required to provide a copy of their most recent pay stub, their latest Federal Tax return (white out social security numbers, etc) and/or any copies of their financial support, such as: FDC, SSI, general assistance, etc.
2. Applicants have an opportunity to provide information on any extra-ordinary expenses, such as: current payment on school loans, uncovered medical expenses and/or situations which may affect their eligibility for financial assistance.

## Application Process

***All applications must be received by June 8th (U9-U19).***

1. Financial Assistance Request Forms will be available online at [www.crsoccer.com](http://www.crsoccer.com) – select the CRSA Scholarship Information and Application.
2. Request forms must be completed thoroughly and accurately, signed and dated.
3. Completed forms and required income documents, etc. must be received by Kris Dekko before the deadline to be considered. CRSA – Attention Kris Dekko, PO Box 10433, Cedar Rapids, Iowa, 52410.
4. **Scholarships are subject to approval by the CRSA Board.** Applicants will be notified on the level of financial assistance.
5. All financial assistance requests will be kept confidential

## Funding

Funding is provided by CRSA. Part of the financial assistance is made possible by charitable contributions to CRSA and through generous friends of CRSA.

Scholarship players have minimum participation and behavior requirements in order to maintain active status. Families are expected to volunteer their time to the club at club activities involving the player's team (fundraisers, tournaments, etc.) Scholarships may be revoked for non-adherence to the above requirements or expectations.

The following chart is a **guideline**, which indicates the Percentage amount CRSA will consider granting. The Parent or Guardian is responsible for paying all remaining fees not covered by the scholarship. This can change per year due to number of the scholarship requests, amount of scholarship funds, etc.

For Example, if a family with a financial need has 3 dependent children and their annual income is \$36,000, then CRSA will consider granting a 70% scholarship and the parent or guardian would pay 30%.
